Regulation
XXXV International Boxing Tournament
memory of the Honored trainer of KazSSR Galym Zharylgapov

1. Goals and objectives

- Perpetuating the memory of the Honored Coach of KazSSR, the master of sports of the USSR Galym Zharylgapov;
- Development and popularization of boxing in the Karaganda region;
- Identification of the strongest boxers, increasing the skill of those involved;
- Strengthening of friendly sports relations of the far and near abroad;
- Performance of the title of Master of Sports of the Republic of Kazakhstan for I place.

2. Date and venue

The tournament is held in the city of Karaganda in the period from December 17 to December 21, 2018, in the center of development of boxing named after S.Sapiev (Prospect of the Republic 11/3). Day of arrival December 16, 2018. The meeting of the credentials committee on December 16 at 4:00 pm in the CDB named after S.Sapiev. Weigh the participants daily from 8.00 hours to 10.00 hours. The grand opening on December 17 at 3 pm.

3. Leadership of the competition

The general management of the organization and holding of the tournament is carried out by the Department of Physical Culture and Sports of the Karaganda Region and the Karaganda Regional Federation of Boxing.

Direct competition is entrusted to the judiciary board approved by the Kazakhstan Boxing Federation, the Department of Physical Culture and Sports of the Karaganda region.

In order to improve the quality of judging an international tournament, teams participating in this tournament are required to have in their composition one judge not lower than the national category, the travel expenses of which are carried out at the expense of sending organizations.

All television and media rights belong to the Karaganda Regional Boxing Federation.

4. Participants of competitions

To participate in the tournament, athletes (men, women) born in 2000 and older who have athletic training not lower than the I-th sports category are allowed. The tournament is held: in 8 weight categories (men) - up to 52 kg, up to 57 kg, up to 63 kg, up to 69 kg, up to 75 kg, up to 81 kg, up to 91 kg, and over 91 kg. Doubling is not allowed.

The formula for men's battles is: - without protective helmet;
- 3 rounds for 3 minutes;
- 5 judges + 1 referee;
- electronic scoring system.

In 5 weight categories (women) - up to 51 kg, up to 57 kg, up to 60 kg, up to 69 kg, up to 75 kg. Doubling is not allowed.

The formula of the battle in women: - with a protective helmet;
- 3 rounds for 3 minutes;
- 5 judges + 1 referee;
- electronic scoring system.

Participants must carry an identity card (passport), insurance policy, medical application with a doctor's admission, AIBA boxer's book and conclusion of an MRI of the brain.

5. Costs

All expenses for the Kazakhstan teams associated with the travel of participants to the tournament (round-trip, per diem on the road, accommodation, meals) are borne by the sending organizations. Teams of the Near and Far Abroad: 5 athletes, 1 trainer, 1 judge. All expenses related to travel to the city of Karaganda and back at the expense of the sending organization. Accommodation and meals on the days of competitions at the expense of the organizers of the tournament (sponsors). One country is allowed from the country.

The rent of CDB named after S.Sapiev, the production of medals, diplomas, the production of an advertising clip, the nutrition of judges, the design of the hall is carried out at the expense of the funds of the UFC of the Karaganda region.

Cash prizes in 13 weight categories, prying and food of the chief judge (supervisor) and appointed judges of AIBA MK, gloves for the tournament participants at the expense of the Karaganda regional Federation of Boxing.

6. Rewarding

Athletes who took 1-3 places are awarded with medals, diplomas from the Department of Physical Culture and Sports of the Karaganda region and monetary prizes from the Karaganda Regional Federation of Boxing. In the nominations "The best boxer", "For the will to win" and "For objective refereeing" are awarded cups from the Karaganda regional Federation of Boxing.

In weight up to 69 kg the winner is awarded with a special prize, established by the sponsors of the tournament.

7. Applications and Confirmation

Confirmation of participation in the International Tournament with indication of the number of participants, judges and officials is provided not later than 10 days prior to the beginning of the tournament and sent to:

Nominal applications with a doctor's note on admission to the tournament are submitted to the chief secretary of the competition on December 16, 2018, at 16.00 hours.

Teams that have not previously confirmed their participation in the tournament organizers at a set time, are not allowed to participate in competitions.

Competitors must have a red and blue boxing uniform.

Teams of near and far abroad must have flag and national anthem.

This provision is an official invitation to the tournament.
