on holding the XI Open International Boxing Tournament, for prizes Champion of the XXX Summer Olympic Games, Val Barker Cup Winner, Honored Master of Sports of the Republic of Kazakhstan S ERIK S APIEV

## 1. GOALS AND OBJECTIVES

- development and popularization of physical culture, a healthy lifestyle and boxing as a sport;
- involvement of children and adolescents in regular sports;
- identifying the strongest boxers, improving the skills of those involved;
- strengthening of friendly sports ties near and far abroad;

#### 2. TIME AND VENUE

Competitions are held from 15 to 20.11.2023 in Karaganda at the Boxing Development Center. Serika Sapieva. Day of arrival November 15, 2023. The meeting of the credentials committee on November 15 from 15.00 to 18.00. Participants are weighed daily from 08.00-10.00. Opening and start of the competition on November 16 at 15.00. Finals November 20, 2023 Departure day November 21, 2023

### 3. COMPETITION MANAGEMENT

The general management of the preparation and holding of competitions is carried out by the NGO "Karaganda Regional Boxing Federation" and the Department of Sports and Sports of the Karaganda Region. Direct conduct is entrusted to the panel of judges, approved by the UVKiS of the Karaganda region.

# 4. COMPETITION PARTICIPANTS

Boys are allowed to compete born in 2008-2009 in weight categories: 44 kg., 46 kg., 48 kg., 50 kg., 52 kg., 54 kg., 57 kg., 60 kg. 63 kg., 66 kg, 70 kg, 75 kg., 80 kg., + 80 kg.

In order to improve the quality of refereeing of an international tournament, the teams participating in this tournament are OBLIGED to have one referee not lower than the national category, whose travel expenses are covered by the sending organizations.

Participants must bring with them: identification card, insurance gender and s, medical application with doctor's approval, IBA boxer's book with annual medical / examination and MRI certificate of the head of the current year.

## 5. EXPENSES

Expenses for Kazakhstani teams related to sending participants to the tournament (round trip, per diems on the road, accommodation, meals) are borne by the sending organizations.

The expenses of the team from near and far abroad (5 athletes, 1 coach, 1 referee) associated with travel to Karaganda and back at the expense of the sending organization. Accommodation and meals on the days of the competition at the expense of the host. Accommodation and meals for additional members of delegations are paid by the participants of the tournament on your own in the amount of US\$ 50 per person per day. One team is allowed per country. Rent CRH im. S. Sapieva, printing products, transport services, services for organizing and holding a tournament, video and photo services, hall decoration, gloves and helmets for tournament participants, memorable prizes, are carried out at the expense of the host.

### 6. AWARDING

Athletes who take 1-3 places are awarded with medals, diplomas and cups. In the nominations "The most technical boxer", "For the will to win" and "For objective refereeing" they are awarded with cups.

A boxer in the nomination "Best Boxer of the Tournament" is awarded a special prize established by the sponsors of the tournament.
